

**CONSENT TO THE PROCESSING  
OF PERSONAL DATA –  
CREATING A DATABASE OF IT  
EXPERTS FOR POTENTIAL  
COLLABORATION ON IT

*pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter the "GDPR")*

**I consent to the processing of my personal data**

**storage period:** Until the consent is withdrawn, not more than 3 years after the end of the last employment or business relationship.

as well as **the provision of my personal data within the scope and for the purpose mentioned above to other entities** so that they can contact me with an offer of potential cooperation.

(hereinafter the "**Consent**")

I also declare that I am aware that the personal data provided is processed by the Controller only on the basis of this Consent. I have no obligation to provide them to the Controller and **I have the right to withdraw this Consent at any time.** If I withdraw this consent, the Controller must delete my personal data provided in this way without undue delay, unless the Controller has another legal basis for their subsequent processing.

**Withdrawal of Consent** can be done by removing the connection with the UDRZATEL GROUP representative, by sending a request to the contact information listed in the header of this Consent or to the address of the Controller's registered office. I shall not be at risk of any detriment from not providing or withdrawing this Consent.

I declare that I am aware of the Controller's Privacy Policy in accordance with Art. 13 of the GDPR in conjunction with Articles 15–22 of the GDPR.

**INFORMATION ABOUT YOUR RIGHTS  
AND OTHER FACTS**

**We will provide the personal data provided to other recipients**, in particular to the marketing company, the website administrator, the IT administrator, social networks within the database (LinkedIn), IT support providers.

You also have the **right of access** to the personal data provided, which you can best exercise by means of a written request to the email address of the Controller indicated in the header of this Consent.

Your personal data is not and **will not be used** for automated individual decision-making or profiling.

We **do not transfer** your personal data to third countries outside the EU.

You also have **the right to rectification or restriction of processing** of the provided personal data if you believe it is incorrect, you have **the right to data portability for transmitting the provided personal data to another controller** or you can request such transmission directly from us, and you have **the right to erasure** of your personal data that you have provided to us.

You can also protect your rights by submitting a complaint to the Office for Personal Data Protection of the Slovak Republic.

You can exercise your rights orally, in writing or electronically, using the contact details above. We will provide you without undue delay with information on the measures taken in response to your request, at the latest within one month of receipt of your request. The Controller may request the provision of additional information necessary for identity confirmation where it has reasonable doubts as to the identity of the natural person who has exercised his or her rights by means of a request for the exercise of a right. It is the responsibility of the Controller to prevent the disclosure of personal data to an unauthorised person. If we need to extend this period in justified cases, we will inform you in due time. If a request for the exercise of rights would be manifestly unfounded or unreasonable, in particular due to its repetitive nature, we may refuse to process your request or we may charge you a reasonable fee taking into account our administrative costs in processing it.
